### Responsibilities and Duties:

- 1. Optimising data management for sustainability reporting.
- Research and Strategy Development: Conduct research to develop sustainability strategies. Conduct peer benchmarking on sustainability reporting practices and ESG ratings.
- Reporting: Assist to prepare accurate and timely sustainability reports, based on the different reporting requirements, such as the Global Reporting Initiative (GRI) standards, Sustainability Accounting Standards Board (SASB) standards, Corporate Sustainability Reporting Directive (CSRD), and standards by the International Sustainability Standards Board (ISSB). This includes analysing, reporting, and communicating ESG-related information.
- 4. Data Analysis: Support in collecting, verifying, and analysing sustainability data for reporting purposes.
- 5. Presentations: Assist in delivering presentations and sharing information and ideas with stakeholders.
